## ***Be faset TI'n wneud.....? Petaet ti'n gweld pethau anhygoel, pethau ofnadwy, y dylai'r cyhoedd wybod amdanynt***

**BRADLEY MANNING** ydi'r milwr Americanaidd 24 oed a oedd yn ddisgybl ysgol yng Nghymru llai na deng mlynedd yn ôl. Bellach mae'n wynebu achos llys yn yr Unol Daleithiau dan gyhuddiad o ryddhau tystiolaeth o droseddau rhyfel, camdrin eang o iawnderau dynol, a diwylliant lle roedd camdriniaeth giaidd yn arferol yn y lluoedd arfog yn y rhyfeloedd yn erbyn Irac ac Affganistan.

**Rydym ni, a llawer o bobl ledled y byd, yn credu fod hyn yn weithred arwrol**, ac os mai Bradley sy'n gyfrifol mae ein dyled yn fawr iddo am sefyll yn erbyn yr anghyfiawnderau cyfoes a'r erydiad o'n bodolaeth dynol.

**Mae wedi newid pethau yn barod. Fe dynnodd yr Unol Daleithiau allan o Irac ddiwedd 2011**, pan benderfynodd Irac, ar ôl cael y wybodaeth, na fyddai milwyr yr U.D. bellach yn rhydd o gael eu herlyn. Bu'r wybodaeth bendant am lygredd a cham-drin gan y llywodraethau gormesol o gymorth i'r **Gwanwyn Arabaidd**. Rydym ni yng "ngwledydd democrataidd y Gorllewin" wedi dysgu beth mae ein llywodraethau'n ei wneud yn ein henw ni. Mae **Cofnodion Rhyfel Irac, Dyddiadur Rhyfel Affganistan, Ffeiliau Guantanamo, y ffilm "Collateral Murder" a Cheblau'r Adran Wladol**, y cyhuddir Bradley o'u rhyddhau, wedi bod yn amhrisiadwy i bawb sy'n deisyfu heddwch a chyfiawnder yn y byd – cawsom wybod y gwir.

**Mae'r dyfyniad ar flaen y daflen yn dangos bwriad anrhydeddus**, eto mae'n rhan o dystiolaeth Llywodraeth yr U.D. yn erbyn Bradley. Dyfyniad arall gan y gwr ifanc (22 ar y pryd) ydi **"Be faset TI'n wneud....?"**

**Mae'n ymddangos fod Bradley wedi gwneud ei ddewis** ac aberthu ei hun i'r gosb mae wedi ei dderbyn yn barod. Mi all wynebu'r gosb eithaf os ceir ef yn euog o un o'r cyhuddiadau yn ei erbyn ac **fe ddisgwylir i lywodraeth yr U.D. ofyn am garchar am oes heb baról**.

**Rwan rhaid i ninnau sefyll yn erbyn anghyfiawnder hefyd**. Er mwyn ein dyfodol, er mwyn Bradley, er mwyn ein hunan-barch, mae'n rhaid i ni fynnu fod Bradley, sydd ddim ond yn euog o ddatgelu troseddau yn erbyn dynoliaeth, nid eu cyflawni, yn cael ei ryddhau, a bod y troseddwy'r go iawn yn cael eu hatal.

**Mae'n amhosib i Bradley gael gwrandawriad teg o dan drefn cyfiawnder milwrol yr U.D.** Mae'r Arlywydd Obama, o bawb, wedi datgan yn barod **ei fod yn euog**. Mae hyn yn amlwg yn erbyn y drefn gywir, y rhagdybiad fod rhywun yn ddieuog cyn y prawf, ac, yn dod o enau cadbennaeth y Lluoedd Milwrol sy'n rhoi Bradley ar brawf, yn dangos dylanwad anghyfreithiol sy'n ei gwneud yn amhosib iddo gael gwrandawriad teg. Mae Bradley wedi bod yn y carchar am bron i ddwy flynedd heb achos llys o gwbl ac am o leiaf wyth mis o dan amgylchiadau anghyfreithlon sydd wedi eu gwrthwynebu gan **Amnest Rhyngwladol, "rapporteur" arbennig y Cenhedloedd Unedig ar gamdriniaeth, ynghyd â nifer o grwpiau a swyddogion eraill**. Mae ei driniaeth wedi cynhyrfu'r cyhoedd mewn nifer o wledydd a thanseilio'r gred yn y sustem gyfiawnder. **Ar ben hynny nid yw'r amddiffyniad wedi cael gweld rhai tystion a thystiolaeth holl bwysig**.

**Felly ymunwch gyda ni i ledaenu'r gair, gadael i'r llywodraeth wybod a gadael i Bradley Manning wybod ein bod ni hefyd yn credu fod hyn yn achos gwerth ymladd drosto.**

## ***What would YOU do....?***

***If you saw incredible things, awful things, that belong in the public domain?***

**BRADLEY MANNING** is the 24 yr old US soldier who, less than a decade ago, was a schoolboy in Wales. He is now on trial in the USA, charged with releasing into the public domain evidence of war crimes, widespread human rights abuses, and a culture of horrific brutality within the armed forces engaged in the wars against Afghanistan and Iraq .

**We, with many people all over the world, believe this is an act of heroism**, and, if it is Bradley who is responsible, we owe him a debt of gratitude for **standing against the erosion of our humanity, and refusing to go along with prevailing injustice**.

**And this has already changed things**. The US **withdrew from Iraq at the end of 2011**, when Iraq, informed by the leaks, refused to grant further immunity from prosecution to US soldiers. The **Arab Spring** has been assisted by hard evidence of the **corruption and abuses of oppressive regimes**. And we, in 'western democracies' have learned **what our governments do in our name**. The **Iraq War Logs, the Afghan War Diary, The Guantanamo Files, the 'Collateral Murder' footage, the State Dept. Cables**, all of which Bradley is accused of leaking, have **proved invaluable to all who seek peace and justice in the world - they have shown us the truth**.

**The quote on the front of this flyer shows honourable intentions**, yet it is part of what the US govt. is using in evidence *against* Bradley. **A further quote from this conversation attributed to the (then) 22 year old young man is 'What would YOU do...?'**

**It appears that Bradley chose what he should do**, and made the sacrifice of risking the punishment he has already been subjected to. One of the charges against Bradley actually carries the Death Penalty, and the **US govt are expected to seek Life Imprisonment without Parole**.

**Now we need to stand up against injustice too**. For the sake of **our future**, for **Bradley**, for **our own integrity**, we need to demand that **Bradley**, guilty, if the allegations are correct, only of exposing crimes against humanity, and not committing them, is **set free**, and that those who are the real criminals are stopped.

**It is impossible for Bradley to receive a 'fair trial' under the US military justice system**. President Obama, no less, has **already declared him to be guilty**. This is plainly **against due process**, and the **presumption of innocence**, and, coming from the Commander in Chief of the Armed Forces Bradley is being tried by, represents 'unlawful command influence' which **precludes a free and fair trial**. Bradley has **been imprisoned for nearly 2 years so far without being tried for anything**, and for at least 8 months in **unlawful conditions protested by Amnesty International and the UN special rapporteur on torture, as well as numerous other officials and groups**. His treatment caused public outrage in many countries, and has **entirely discredited the judicial process**. And the defence has been **refused access to key witnesses and evidence**.

**So join in with us in spreading the word, in making it known to government, and letting Bradley Manning himself know, that we, too, believe this is a cause worth fighting for.**
